Numerous Glendale residents report that MPHA staff and their partners are telling them that they have to move out or that the Glendale Townhomes will be

demolished. MPHA staff and their partners have done this at residents' annual income recertification meeting, and knocking on their doors and telling them in person. This is deeply concerning, unethical, and manipulative behavior. It is important that all residents know the following:

- No decisions have been made about the future of Glendale. **No one** needs to move out.
- Section 8 vouchers are almost **impossible** to use in Minneapolis. Permanent housing is **not** guaranteed with a Section 8 voucher.
- Do not listen to any MPHA staff or anyone else who tells you that you have to move or who says that Glendale will be demolished—these are **lies** to mislead and intimidate residents.
- Please inform your neighbors about these lies and rumors. Do not let MPHA or Biko Associates staff intimidate you! Do not be afraid to tell MPHA that you refuse to move out of Glendale.
- Get involved with Defend Glendale to learn more about MPHA's plans, and have your voices heard by City Councilmembers, MPHA, and others. Be a part of the decision-making!
